Dear Parents, Carers and Friends of Thongsley Fields,

I am writing to formally notify you that the Interim Executive Board (IEB) for Thongsley Fields Primary and Nursery School is considering the school becoming an academy joining the Cam Academy Trust and as part of the process we are consulting with all parts of the school community. The consultation period will run from the publication date of this letter until noon on 5th March 2018.

The consultation document with this letter gives much greater detail about the proposal and it may answer all your questions or concerns. This document has been prepared by the IEB in conjunction with the school, the LA and the Cam Academy Trust. It can be found via this link

If there are any issues that you would like us to consider or questions that you would like to have answered then there are three ways in which you can bring them to our attention.

- Come to a Consultation meeting at Thongsley Fields School on: 26th February at 2.30 - 3.15pm or 5.00 - 6.30pm. (It does not matter which of these meetings you attend or if you cannot stay for the whole meeting.)

During the meetings you will be able to talk to members of the IEB, the Interim Headteacher and Officers from the Cam Academy Trust and, whenever possible, get your questions answered immediately. If you are unable to come to a meeting and your question is not covered in the attached consultation document please contact us by email or by using the form below.

The consultation process will finish at noon on 5th March 2018. All questions or comments should be received by that date; any communication after that date may not be able to be considered. We will produce a summary document of the all comments, questions and any responses which will be sent to all interested parties. If you submit a written question please let us know how we can contact you if you require a personal response.

All questions and comments received will be considered and a final decision will be made by the IEB. The IEB will meet at the end of the process to consider everything arising from the consultation period before making their final decision about becoming an academy and joining the Cam Academy Trust. We recognise that the final decision rests with the Regional School Commissioner on behalf of the Secretary of State.

The IEB believes that converting to an academy is in the best interests of the children and all other members of the school community. We want you to be convinced as well and are keen to receive your comments and questions.
